

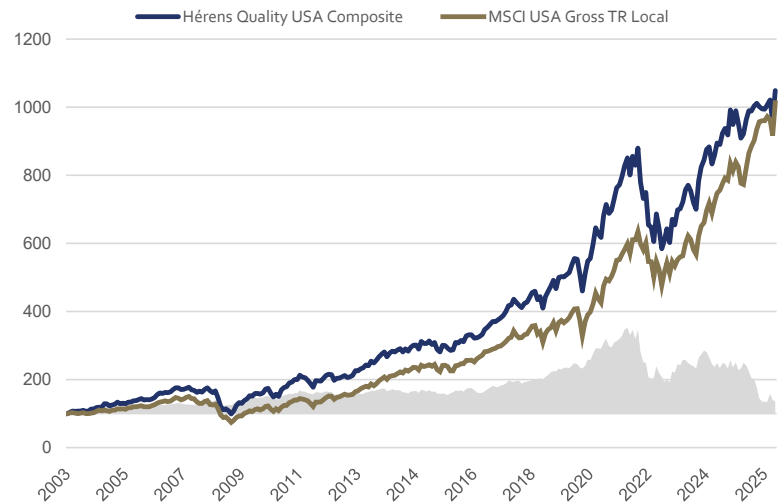
## Quality USA Equity Composite

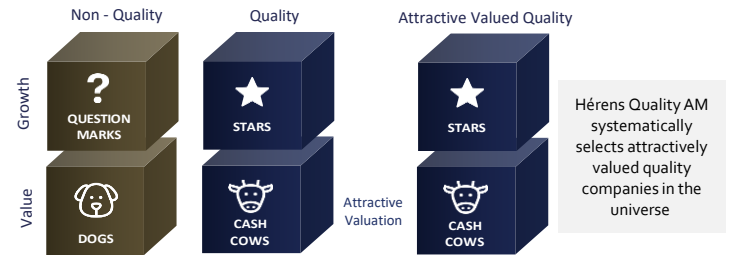

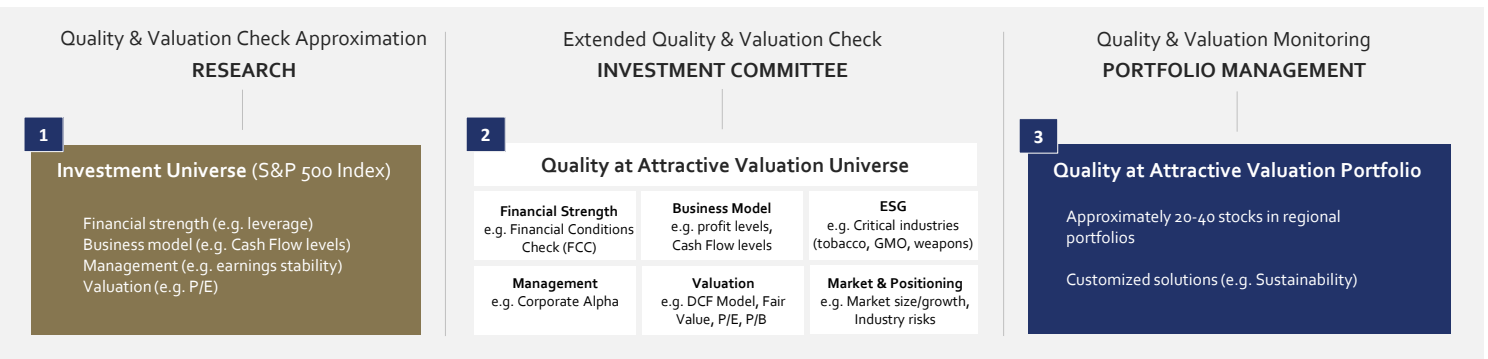
